

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. On Course Riding Academy LLC has put in place preventative measures to reduce the spread of COVID-19; however, On Course Riding Academy LLC, Inc. cannot guarantee that you and/or your child(ren) will not become infected with COVID-19. As is the case with any public facility, the attendance at a horse show, even at an outdoor venue, may expose you to the COVID-19 virus. Your decision to enter the competition or attend the horse show, and access the facilities and grounds is made knowingly and voluntarily by you with full knowledge of this risk. You will be responsible for social distancing and any other safety precautions.

Further, attending the horse show could increase your risk and/or your child(ren)'s risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending a horse show and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a horse show may result from the actions, omissions, or negligence of myself and others, including, but not limited to, On Course Riding Academy LLC. Its employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at or participation in On Course Riding Academy LLC's. horse shows ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless On Course Riding Academy LLC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of On Course Riding Academy LLC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any On Course Riding Academy LLC event.

If you choose to enter the showgrounds, you assume the risk for your possible exposure to COVID-19. If you disagree, please do not enter the showgrounds. Entrance to the showgrounds will constitute a waiver and release of On Course Riding Academy LLC and any of its affiliates from any and all liability with respect to Exposure to the COVID-19 virus.
